## Rules, Regulations, & General Information

AGE: Dogs enrolled in day care must be old enough to have had all three distemper parvo combo shots as well as the rabies vaccine.

SEX: All female dogs are welcome with the exception of those in heat. All male dogs who are unaltered and over the age of 12 months will not be accepted in our Daycare. Also, male dogs who are unaltered after the age of 6 months and up to 12 months and exhibit unaltered male tendencies and / or aggression will no longer be able to attend daycare until altered and reintegrated into our daycare.

VACCINATIONS: Owners are required to provide proof of current vaccinations (distemper, parvovirus, rabies).

**Bordatella vaccinations are optional.**

HEALTH: All dogs must be in good health; owners will certify their dog(s) are in good health and have not been ill with a communicable disease within the last 30 days. Upon enrollment, all dogs must be free from any condition that could potentially jeopardize the health or safety of other clients. Dogs who have been ill with a communicable disease in the last 30 days will require a veterinarian's certification of health to be admitted or re-admitted. **No dogs will be allowed to attend day care with visible stitches or bandages or cones.**

BEHAVIOR: Generally, all dogs must be non-aggressive and not overly food or toy protective. **Should your dog exhibit any behaviors deemed unsafe during their enrollment in our daycare program, Paws Plaza staff will have authority to remove your dog from its daycare program permanently.** Please remember your dog(s) will be spending time with other dogs and the safety, health, and enjoyment of all clients is our primary concern. We do work with some dogs with problematic behaviors, who may require additional training *at additional cost*.

APPLICATION AND AGREEMENT: All dogs must have complete, up-to-date, and approved Application and Pet Personality Profile and Client Agreement forms on file.

## Client Agreement

- 1) I understand that I am solely responsible for all harm and damages caused by my dog(s) while he/she is attending daycare, classes, or any other services provided by Paws Plaza. I further understand that if there is an incident between dogs that result in the need for medical attention, each owner is solely responsible for their own veterinary bills relating to the incident. - 2) I agree to inform Paws Plaza of all risks associated with my dog that are known to me, or that should be known to me, whether or not such risks are specifically asked about on the *Pet Personality Profile*. If I fail to inform Paws Plaza of such risks, I understand that I am responsible for all losses or damages caused by my failure to properly inform Paws Plaza.
- 3) I shall indemnify and hold harmless Paws Plaza against any and all claims, demands, damages, and costs, including attorney's fees, made against it based on injury or damages caused by my dog while in the care of Paws Plaza.
- 4) I further agree to indemnify and hold harmless Paws Plaza from damages and injury caused to myself, or others that accompany me onto Paws Plaza's premises, provided reasonable care and precautions are taken by Paws Plaza. I agree not to leave children unattended at Paws Plaza.
- 5) I hereby release Paws Plaza from any liability, claims, demands, damages, and costs, including attorney's fees, of any kind, known or unknown, arising from my dog's attendance and participation at the daycare, overnight care, classes or other services.
- 6) I further understand and agree that any problem that develops with my dog(s) will be treated as deemed best by Paws Plaza staff in their sole discretion, and I assume full financial responsibility for any and all expenses involved. I recognize and understand that if my dog(s) becomes ill, or if the state of the dog's health otherwise requires professional attention, Paws Plaza, at its sole discretion, may engage the services of any veterinarian of Paws Plaza's choice, may administer medicine, and may give other requisite attention to the dog. I thereof shall pay all expenses and I expressly authorize, by signature below, that all such charges for medical services will become my responsibility.
- 7) I further understand and agree that in admitting my dog(s) to Paws Plaza, the facility has relied upon my representation that my dog(s) is/are in good health and have not been ill with any communicable condition in the last 30 days. I further certify that I have informed Paws Plaza about any and all past incidents wherein my dog has harmed, threatened, or behaved aggressively towards any persons or other dogs.
- 8) *I have initialed each statement below to acknowledge my understanding and acceptance:*
  - A. I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include but are not limited to, illness due to sharing toys or common water bowls, problems resulting from rough play such as soreness or stiffness, ingesting unknown foreign objects, and/or uncontrolled animals outside our facility.
  - B. I recognize that there is an inherent risk of fighting or disease transmission, resulting in possible injury or death, when commingling dogs from different backgrounds, with different temperaments, different medical and treatment histories, who are owned by different individuals.
  - C. I agree that each owner is solely responsible for any injuries or veterinary bills that may result from an incident between dogs..
  - D. In event of emergency, I give Paws Plaza permission to take my dogs off site, as deemed appropriate and necessary by Paws Plaza staff members.
  - E. I certify that I have read and understand the rules and regulations set forth by Paws Plaza and have read and understand this agreement. I agree to abide by the rules and regulations and accept all terms, conditions, and statements of the agreement.
